Public forum

Napier Neighbourhood Support Group (NNSG) – Jason Wawatai (Chairperson) and Adrianne Galvin

Adrianne and Jason gave a brief update of what the Napier Neighbourhood Support Group is about. In particular they noted:

- The results of a Police survey conducted in Auckland found the majority of respondents between the ages of 15 and 25 felt the safest out of all surveyed, although they were the most at risk age group, as they tend to put themselves in risky situations. The 60+ age group were the ones who felt most unsafe, although they are the most safe as they do not put themselves in harm's way.
- Since Napier City Council's (NCC) Community Safety Survey was carried out in February Jason's impression is that community feelings of safety will have declined after some significant incidences of violence in Napier.
- The focus of NNSG is to support the NCC's Safer Napier policy in its endeavours to
 provide the community with a sense of community safety, crime prevention assistance,
 collaboration with stakeholders to achieve common safety outcomes and enhance the
 sense of wellbeing amongst the neighbours in the community.
- It will continue to provide a service that supports the NCC's objectives, the NCC's international accreditation status as a Safe City, the safe as houses programme, and to help build resilience within the Napier Community.
- They establish new Neighbourhood Support Groups and support existing groups, although this has challenges as people move and do not update NNSG. NNSG reorganises defunct groups, providing resources to new members and notifying groups of actual and potential local crime activity.
- Police provide crime statistics to NNSG which they can then distribute to relevant neighbourhood groups.
- NNSG would like to see high wooden fencing banned from use as crime can occur behind them unseen.
- NNSG has 22,000 members from 8000 households. There has been a surge in single people wanting to join NNSG, not so they can attend neighbourhood meetings, but so they are included in information distribution about their area.
- NNSG's membership is growing, but they would like more members, 25 45 year olds in particular. NNSG talks to community groups and attends community events. They also aim to educate community leaders so they can talk about NNSG to their groups.
- People can sign up to NNSG through a variety of ways, the most popular is through 'Get Ready' and the Facebook page. NNSG then connects them with a nearby neighbourhood group and sends an information pack.

1.1 Purpose of Report

To provide a summary of findings from the Napier Community Safety Survey 2021.

At the Meeting

Council Officers spoke to the report and were supported by Dr Virgil Troy and Nataliya Rik from SIL research.

In response to questions it was clarified:

- Approximately ten of the survey questions were the same as questions in the Annual Social Monitor Survey. There were also safety focused questions included.
- Council supports opportunities and activities that promote alternative pathways for gang members, or those at risk of joining gangs. It also liaises closely with Police around managing and responding to anti-social gang and criminal behaviour.
- Safety strategies which are being implemented, such as the new street
 Ambassador service, will have their own measures of success. It may also be
 possible to see some results of the new safety strategies in the next Social
 Monitor Survey.
- Advocating for more Police in Napier City needs to be carried out at the governance level.
- Council support the Napier Safety Trust, who currently manage and monitor the non-Council facility CCTV cameras. The CCTV network is due for an upgrade, but no increase in cameras is planned.
- Police continue to share data with Council on where crime is happening, and what sort of crime it is. Both organisations have a role to play in reassuring the community and to increase people's perceptions of safety.
- Community members who are members of a Neighbourhood Support Group report feeling safer than non-members. These residents are more predominantly in an older age bracket. The survey has not measured the correlation between being aware of the Safer Napier activities and feelings of Safety, but this could be measured in future surveys.

2. AQUATICS SURVEY 2021 REPORT: SIL RESEARCH

2.1 Purpose of Report

The purpose of this report is to inform council of the results of the SIL Aquatics Survey 2021 and the implications that these customer insights have on future asset and operational improvements.

At the Meeting

The Officer took the report as read. They were supported by Dr Virgil Troy and Nataliya Rik from SIL research and in response to questions noted:

- The results of the Aquatics Survey are consistent with the Napier Resident Survey data, which has been administered annually over the last ten years.
 Where a change has been noticed has been around the condition of the pools which has been slowly degrading over time.
- The sampling for this survey was carried out over different days and at different times of day. One of the reasons younger people are not represented significantly in the results is that parents responded on behalf of their families.
- There is a general decline in physical activity by youth across most sports. There are many reasons for this, including accessibility and affordability.
- Cleanliness has been sighted as a reason for not attending the aquatic facilities.
 As both locations are old surfaces can appear unclean, but actually are degraded so appear unclean despite regular operational cleaning.
- Trouble-makers at the facilities can be trespassed. Security guards have been
 installed to deter anti-social behaviour. They are also helping with tips on
 managing difficult situations and staff are given training on dealing with difficult
 customers.
- The Green Family Taradale Pool is competition for the Council facilities in the 'Learn to Swim' area, but it is not available to the public for recreation.
- Public pools used for recreation do not make a profit. Council subsidises its aquatic facilities by approximately \$8 \$11 per person, per visit.
