#### **Public forum**

**Māori Movement – Theresa Carter (formerly O'Brien) together with Ngarino Te Waati** displayed a powerpoint presentation (*Doc ID 1364352*) providing a brief overview of the highlights, challenges and outcomes of 10 weeks in the Whānau Transformation Programme for participants in the Maraenui and Waiohiki Cohorts. An in-committee session had been held prior to the meeting to protect the participants as they spoke of the changes that were happening and the backgrounds in their lives.

Success factors enabling whānau participants to experience transformational changes were:

- 1. Accessibility to te ao Māori and the source (knowledge growth)
- 2. Opportunities to apply learning (transfer learning into everyday life)
- 3. Relationships (sustainability)
- 4. Exemplary leadership (guidance, respect, trust)

Theresa had been in the community and social service sector for several years and said there were people who through the programme were now well advanced in conquering issues such as methamphetamine addiction.

**Rebecca Clark** spoke as a participant in the Waiohiki programme and spoke of her ten week experience in the programme.

The programme was a Māori Movement for health and wellbeing which provided sustainable solutions for transformational change within individuals, whānau, hapū and iwi using Māori traditional methodologies.

Māori Movement were working together with the Ministry of Defence and Ministry of Social Development using Māori frameworks which could not be compared to clinical practise and being open from a Māori perspective.

The outcomes based evaluation of the Māori Movement Whānau Transformation Programme independent final report was circulated.

This item presents recommendations from the Clifton to Tangoio Coastal Hazards Strategy Joint Committee (Joint Committee) and seeks a recommendation from Council on how to progress next steps to implement the Clifton to Tangoio Coastal Hazards Strategy (the Strategy).

Following the completion of a review (Funding Review) to consider which Council should lead and fund the implementation of coastal hazard mitigation projects under the Strategy, the Joint Committee met to consider the report's recommendations and recommend the way forward to the Partner Councils. It is now necessary for each of the Partner Councils to agree (or not) the findings of the Funding review to enable implementing the Clifton to Tangoio Coastal Hazards Strategy and its coastal hazard mitigation projects.

The key recommendations of the Funding Review are that the Hawke's Bay Regional Council takes charge of all aspects of the prevention and mitigation of coastal hazards

on the Clifton to Tangoio coast and that the Napier City Council, Hastings District Council and Hawke's Bay Regional Council enter into a memorandum of understanding setting out agreed positions on this arrangement.
