#### Announcements by the Chairperson

The Chair welcomed new staff members Roger Morrison and Margot Wilson to the Community Funding team, following the retirement of Belinda McLeod former Community Funding Advisor.

#### Announcements by the management

**Feedback** - The Community Funding Advisor, Mr Morrison advised that Smarty Grants was a flexible tool and welcomed feedback from the members of the Subcommittee on the assessment process to enable the administration staff to determine if any changes could be made to improve the process. Feedback could be emailed to Mr Morrison at roger.morrison@napier.govt.nz.

**Funding Review** - At the meeting held 26 June 2023 the Committee had requested that an increase in the per capita payments from \$1.80 to \$2.00 be investigated as part of the Community Services Grant (CSG) review. The subsequent CSG review made no mention of the per capita payments being adjusted. Mr Morrison advised that the last per capita funding increase had been in 2018 and that the amount of increase each year was based on the cost of living increase.

A review was currently underway to develop a framework to rationalise consistency across Council's grant funding. A workshop on the Funding Framework was held with elected members on Thursday, 4 July 2024. As part of that review, there will be a recommendation to look at the per capita rates. An audio recording of this workshop was available on Council's website Workshops | Napier City Council.
